Life Skills joined the fun times being provided by our ECL Program, by offering a virtual class to our consumers who could not attend program. The class offered was “Get on Up” which was an exercise class designed for both wheelchair and non-wheelchair users. The class was instructed by Life Skills staff to consumers who were at home and had access to either an I-pad, computer, or smart phone. The class was held two times a week on Tuesday P.M., 1:30-2:30 and Thursday A.M., 9:30-10:30.

The virtual class was well received, so the ECL Program extended an invitation for our Life Skills group to join in on their established virtual classes, which included a “Social Club” on Monday mornings, and a “Virtual Tour Group” on Tuesday mornings. Joining those classes was such a hit, that as of October 1, 2021, the Life Skills program has expanded our classes that now include:

Tuesday “Get on up” Exercise Class, 1:30-2:30 P.M.

Thursday “Get on up” Exercise Class, 9:30-10:30 A.M.

Wednesday “Book Club”, 9:30-10:30 A.M. In this class, the group chooses a book and Life Skills staff reads the book while engaging them in questions, answers, and conversation.

CESSC's Inclement Weather Procedures

If we are forced to close programs due to inclement weather it will be broadcasted on the following TV and Radio stations: Fox 2 Detroit, Local 4 – WDIV, Channel 7- WXYZ, Channel 62, Channel 50, WWJ 950, WJR AM 760. It will also be posted on our Facebook Page.

Participants Who Ride BWAT Busses to and From Program:

BWAT's policy is to follow whatever Woodland Developmental Center does, so if Woodland is closed then they will not run their routes. The first route that BWAT operates leaves the bus garage at 5:30 a.m. so if they have individuals on their busses and then hear that Woodland is closed; they will return people back home. Keep in mind that BWAT makes the decision to operate their bus routes and we have no control over this decision.

Participants Who Ride Community Enterprises Vans to and From Program:

If BWAT is operating, then we will be providing transportation. If Blue Water Area Transit cancels transportation, then we will as well, and program will be closed for the day.

It is the practice of Community Enterprises to open program whenever possible. However, in the event of unforeseen circumstances such as adverse weather and facility issues we may have to close program.
